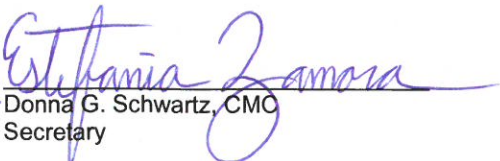

RESOLUTION APPROVING THE SUCCESSOR AGENCY TO THE FORMER HUNTINGTON PARK REDEVELOPMENT AGENCY MAKING CERTAIN FINDINGS RELATING TO THE CITY OF HUNTINGTON PARK'S CREATION OF A COMMUNITY REVITALIZATION INVESTMENT AUTHORITY TO OPERATE WITHIN THE COMMUNITY

IT IS RECOMMENDED THAT THE SUCCESSOR AGENCY BOARD:

1. Adopt Resolution No. SA 2017-03, Making certain findings relating to the creation of a Community Revitalization Investment Authority to operate within the Community.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

In 2015, the State of California adopted AB2/AB 2492 known as the Community Revitalization and Investment Authority (CRIA), which was designed to restore redevelopment authority to disadvantaged communities based on certain provisions of former Community Redevelopment Law. CRIA provides new authority to revitalize communities through planning and financing infrastructure improvements and upgrades; economic development activities such as new major retail developments; and affordable housing via tax increment financing.

On December 6, 2016, the City Council directed City staff to move forward on formation of the CRIA. The first step in the creation of the CRIA requires the adoption of a resolution by the City Council. In addition, the Successor Agency must confirm through a resolution that it has met the finding of fact listed in the section below.

FISCAL IMPACT/FINANCING

These actions do not have a fiscal impact to the Successor Agency Budget.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

Pursuant to subsection (b)(3) of Section 62001, and based upon staff presentations and reports, public testimony, and other matters presented during its consideration of this matter, the Successor Agency hereby makes the following findings of fact:

(A) The Successor Agency has received a finding of completion from the Department of Finance pursuant to Section 34179.7 of the Health & Safety Code, with such finding of completion dated April 12, 2013;

(B) Neither the City or the Successor Agency is currently or has been a named plaintiff in any litigation against the state in which assets of the Former Agency are the subject, and accordingly no assets of the Former Agency which are the subject of such litigation will be used to benefit any efforts of the Authority, and further that no assets of the Former Agency which may be the subject of any such future litigation will be used to benefit any efforts of the Authority unless such litigation has been resolved by entry of a final judgment by any court of competent jurisdiction and any appeals have been exhausted; and

(C) The Successor Agency has complied with all orders of the State Controller pursuant to Section 34167.5 of the Health & Safety Code, as such orders and the Successor Agency's compliance therewith are evidenced by the State Controller's Asset Transfer Review for the Community Development Commission of the City of Huntington Park, dated November 26, 2014.

CONCLUSION

Upon approval by the Successor Agency and Oversight Board ROPS 17-18 will be forwarded to the County Auditor Controller and DOF and posted on the City's website.

WHEREAS, the California Legislature approved Assembly Bill 2 (Stats. 2015, c. 319, as amended), and thereby enacted Part 1 (commencing with Section 62000) of Division 4 of Title 6 of the Government Code (the “CRIA Law”) to create a planning and financing tool for local governments to address areas characterized by unsafe or unhealthy buildings in which persons live or work, conditions that make the viable use of buildings or parcels difficult, high business vacancies and lack of employment opportunities, and inadequate public improvements, water, or sewer utilities;

WHEREAS, a CRIA formed by a city that created a redevelopment agency that was dissolved pursuant to Part 1.85 (commencing with Section 34170) of Division 24 of the Health & Safety Code (the “Dissolution Law”) may not become effective until the successor agency of the former redevelopment agency has adopted findings of fact that satisfy the requirements of subsection (b)(3) of Section 62001 of the Government Code;

WHEREAS, the City of Huntington Park has heretofore created a redevelopment agency, known as the Huntington Park Redevelopment Agency (“Former Agency”), which was dissolved by virtue of the Dissolution Law, and the Successor Agency to the Former Agency (“Successor Agency”) is charged with overseeing and effectuating the “wind down” of the Former Agency’s affairs in accordance with statutory mandates;

1 **WHEREAS**, the City Council of the City of Huntington Park will,
2 contemporaneously with adoption of this Resolution, consider the creation of the
3 Huntington Park Community Revitalization Investment Authority ("Authority")
4 pursuant to the CRIA Law; and

5 **WHEREAS**, the Successor Agency desires to facilitate the creation and
6 effectiveness of the Authority by adopting this resolution making the findings set
7 forth in subsection (b)(3) of Section 62001 of the Government Code; and

8 **WHEREAS**, all other legal prerequisites to the adoption of this Resolution have
9 occurred.

10 **NOW THEREFORE, THE SUCCESSOR AGENCY TO THE FORMER**
11 **HUNTINGTON PARK REDEVELOPMENT AGENCY HEREBY FINDS,**
12 **DECLARES, AND RESOLVES AS FOLLOWS:**

13 **SECTION 1.** The foregoing recitals are true and correct and incorporated
14 herein this Resolution as substantive findings.

15 **SECTION 2.** Pursuant to subsection (b)(3) of Section 62001, and based upon
16 staff presentations and reports, public testimony, and other matters presented
17 during its consideration of this matter, the Successor Agency hereby makes the
18 following findings of fact:

19 (A) The Successor Agency has received a finding of completion from the
20 Department of Finance pursuant to Section 34179.7 of the Health & Safety Code,
21 with such finding of completion dated April 12, 2013;

22 (B) Neither the City or the Successor Agency is currently or has been a
23 named plaintiff in any litigation against the state in which assets of the Former
24 Agency are the subject, and accordingly no assets of the Former Agency which are
25 the subject of such litigation will be used to benefit any efforts of the Authority, and
26 further that no assets of the Former Agency which may be the subject of any such
27 future litigation will be used to benefit any efforts of the Authority unless such
28 litigation has been resolved by entry of a final judgment by any court of competent
jurisdiction and any appeals have been exhausted; and

 (C) The Successor Agency has complied with all orders of the State

and the Successor Agency's compliance therewith are evidenced by the State

1 Controller's Asset Transfer Review for the Community Development Commission of
2 the City of Huntington Park, dated November 26, 2014.

3 **SECTION 3.** The Secretary of the Successor Agency shall certify to the
4 adoption of this Resolution, and it shall become effective immediately upon
5 approval.
