1. Discussion on the Second Annual LGBTQ+ Family Resource Fair on February 1, 2025.

Vice Chair, Baltazar, confirmed 9 vendors have confirmed and inquired if supplies are available for the event. PLEDGE OF ALLEGIANCE- Vice Chair Baltazar led the Pledge of Allegiance

PUBLIC COMMENT - Former commissioner, Ebony Batiste, stated she enjoyed the work she has done and thanked the commission for their service. Vice Chair Baltazar and Interim Director Infanzon thanked her for her 8 years of service. Commissioner Delgado wants an explanation of the decision and was informed that when a council member is no longer in the office their appointments are removed. Vice Chair Baltazar adds that she would like to add a rule about how many times a commissioner can be absent before being removed from the commission. Staff stated the commissioner has been removed and replaced at the last city council meeting. Interim Director Infanzon says he will bring in verbiage from the municipal code, if any.

REGULAR MEETING AGENDA

1. Discussion on Spay and Neuter Program

Vice-Chair Baltazar asks if flyers have been created. Staff have informed the commission the Downton Dog Rescue (DDR) will have a flyer available in two weeks if not staff will create the flyer. Interim Director Infanzon gives a summary of events and informs the commission there is a waiting list for the Spay and Neuter Program and the Police Department currently manages the program. Vice Chair Baltazar asks what the role of the commission is. Interim Director Infanzon informed them they have completed their role for the event and will provide them with more updates on the waitlist once received from the Police Department.

2. Discussion on the Graciela Ortiz Little Library Program

Project Manager Ahumada informs the commission that the proposed library locations are equally distributed around the city. Vice Chair Baltazar asks if the \$5,000 per year includes the cost of maintenance and the purchase of books. Commissioner Delgado says she was in contact to receive donated books. The Interim Director says there is no budget for maintenance and that a percentage should be allocated towards that. Project Manager Ahumada confirms that flyers will be made and posted in social media and parks. The commissioners spoke about having an inauguration of the Little Library locations once they have been installed. Interim Director Infanzon will request approval for the event. The commissioners would like 2 additional library locations to be picked by staff for the following meeting.

3. Discussion on Huntington Park 5k

Commissioner Delgado says the program "Walk to Run" has been a success and there have been a lot of signups for the event. Vice Chair Baltazar asked staff to order a banner. Commissioner Fabian asked for more crayons. Project manager Ahumada requested an email with the supplies proposed by the commission to purchase correct items. Commissioner Delgado will be available for the event. Interim Director Infanzon says a tablecloth would be more useful than a banner. Commissioner Fabian says pins and pencils were a big hit last year and is wondering if it can be done again. Commissioner Delgado asks if we can have tables for activities.

4. Request to change the meeting date.

Commissioner Fabian requested staff to propose dates for the monthly commissioner's meeting. Vice Chair Baltazar is unable to attend on Thursdays. Commissioner Delgado is unavailable to attend on the 2nd Tuesday of the month. Commissioner Fabian has no current conflicts. Staff to provide proposed dates that work within the stated time restraints and city's calendar of events.

5. Third annual LGBTQ+ family Resource Fair 2026

Vice-Chair Baltazar mentioned the current political climate has caused a decline in event attendance due to fear. She proposes the next event to be held in an open area during the first Saturday in February 2026 in Keller Park, weather permitting. She will provide a list of vendors for certificates.



SPAY AND NEUTER PROGRAM

IT IS RECOMMENDED THAT THE HEALTH AND EDUCATION COMMISSION:

1. Update of the Downtown Dog Rescue (DDR) event.

BACKGROUND

On April 18th, 2024, the City Council of Huntington Park approved Resolution 2024-07, which authorized funding for the Huntington Park Special Legacy Project, namely, the Spay and Neuter Program. The allocation is \$25,000 and will be provided over a five-year period. It was established in response to the City's recognition of the need for responsible pet ownership, aims to reduce the number of unsheltered animals within the community and promote the well-being of pets. The Health and Education Commission, in partnership with the DDR, will oversee the development and implementation of the Spay and Neuter Program.

The first event is a wellness clinic offering a mini examination, along with an opportunity for pet owners to consult with medical staff regarding any questions or concerns about their pets. Services will include vaccinations and microchipping. Then they will schedule the pet surgeries. This program is exclusively available to dogs and cats belonging to residents of Huntington Park. This event is scheduled for May 3, 2025, from 10:00 AM to 12:00 PM at the Salt Lake Park parking lot. The event is by reservation only, and walk-ins will not be accepted. DDR provided the flyer.

STAFF RECOMMENDS DISCUSSION OF THE GRACIELA ORTIZ LITTLE LIBRARY PROGRAM

IT IS RECOMMENDED THAT THE HEALTH AND EDUCATION COMMISSION:

BACKGROUND

On April 18th, 2024, the City of Huntington Park City Council approved Resolution 2024-06 funding \$25,000, over a 5-year span, for the program. The city recognizes the importance of promoting literacy and community engagement amongst all its residents with an emphasis on students and the youth population. Staff have recommended 4 little library boxes locations Salt Lake Park, Chesley Park, Freedom Park, and Raul R. Perez Memorial Park and are requesting commission approval to purchase. Two new locations are pending commission approval.

The cost for a little library and pole from the Little Library Organization is \$665.

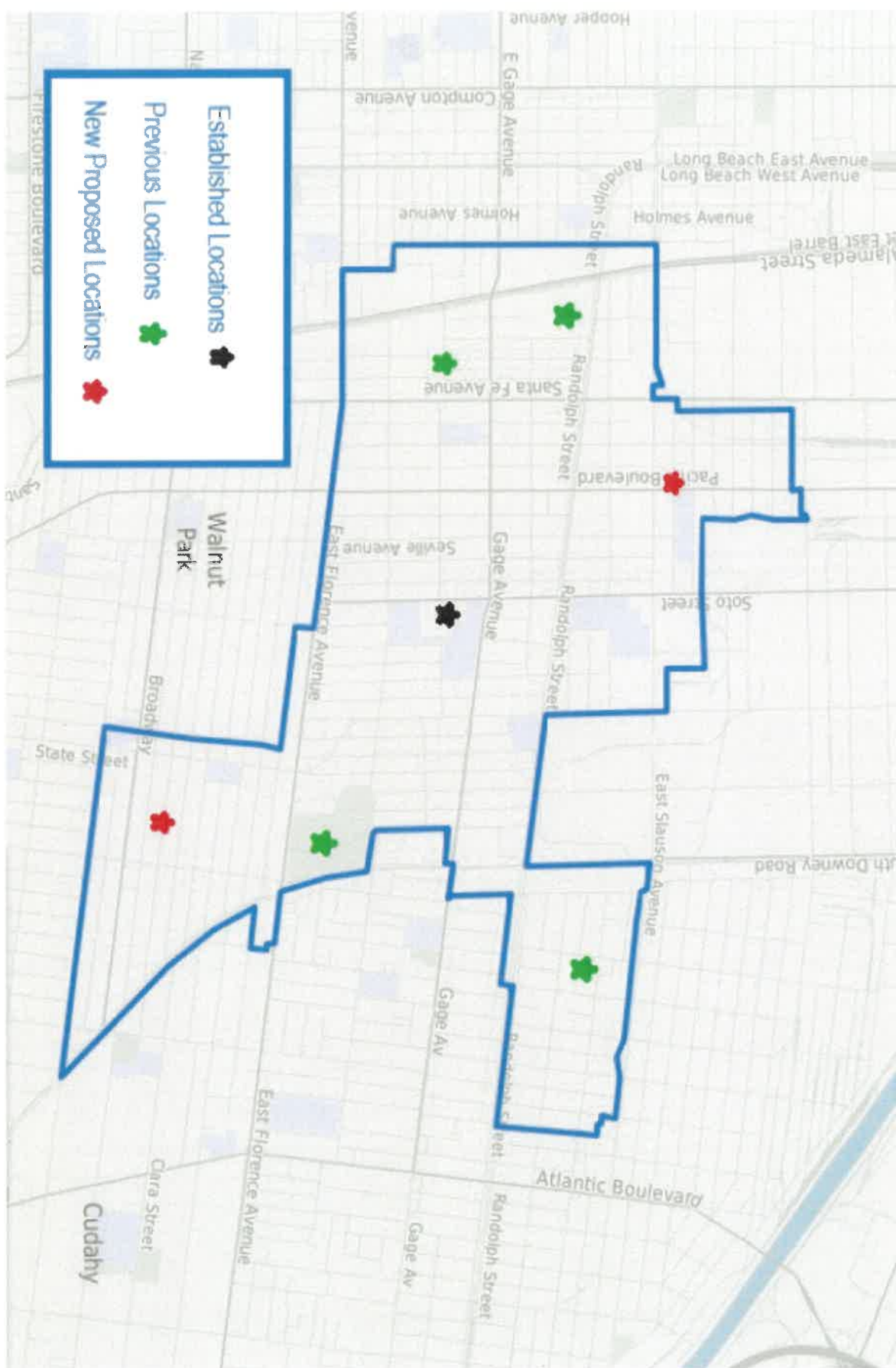
