

**Minutes of the Regular Meeting of the City of Huntington Park  
Health and Education Commission

A discussion ensued regarding the April 1<sup>st</sup> event at the Robert H. Keller Memorial Park as well as the closure of miles. Mr. Garcia requested the Commission to attend the City Council meeting on Monday, March 1. Mr. Garcia stated that the request for additional funding will be presented at the Council meeting. Mr. Garcia added that Assistant Planner Silva is currently processing the paperwork with the Parks and Recreation Department for the use of the Robert H. Keller Memorial Park.

Chairperson Savage requested that an ad-hoc committee meeting be held on Tuesday, March 2 at 11:00 am to discuss the use of the additional funding of \$2500, if approved by the City Council.

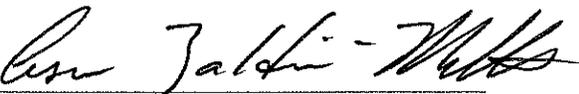
Planning Manager Garcia stated that staff has received the following quotes on the banners: 3x10 \$120, 3x12 \$145 and 4x10 \$175.

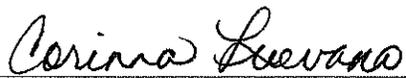
