1. 6330 Rugby Avenue, #612. Request for Blue Curb. Request was denied due to the apartment complex having more than five (5) residential dwelling units. Condition part of the Blue Curb Policy.
2. 6330 Rugby Avenue. Request to re-install 2 loading/unloading zones that were previously removed per the March 1, 2018 TA Item No. C1.
3. Aspire Pacific Academy, 2565 E 58<sup>th</sup> Street. Request to make alley north of the school into a one-way alley.
4. Wilmington Avenue between 64<sup>th</sup> Street and 65<sup>th</sup> Street. Request that the entire perimeter curb be painted red to prevent any vehicle parking.
