#### C. PREVIOUS ITEMS

1. All residents/business owners were notified via phone and/or email of the Traffic Authority (TA) decisions regarding their agenda item/request from the December 6, 2018 meeting.

#### D. NEW ITEMS

1. State Street between Saturn Avenue and Florence Avenue. Pedestrian crossing safety concerns.
2. 4079 Santa Ana Street. Request for 20-minute Green Curb. Further information from the applicant was needed to consider a 1 to 2-hour parking limit. TA Staff communicated with the petitioner and the petitioner concurred a 1 to 2-hour parking restriction sign posted at this location will likely solve the problem.
3. 2513 Gage Avenue. Request for 20-minute Green Curb.

#### E. UPDATES

1. Gage Avenue/Bissell Street & Gage Avenue/Hollenbeck Street. Residents' concern for uncontrolled crosswalks.
  - The Board heard a group of residents expressing concern during Open Forum in the last meeting on this non-agenda item regarding Rectangular Rapid-Flashing Beacons (RRFB) units recently removed from these locations.
  - The Traffic Engineer is to review previous studies on signal warrants at

- these unsignalized intersections.
2. 6868 Benson Street. Request for All-Way Stop Control.
    - The application was denied, and the Traffic Engineer was asked to see if this intersection qualifies for Safe Routes to School since it is near a school, and if so, add crosswalks. Furthermore, since this area is part of the City's ATP Cycle II project, the recommendation was to maybe take out the ladder crosswalks at Plaska Avenue/Saturn Avenue, maybe look at the westbound traffic from Saturn on Benson, do a parking analysis, and address sight line issues, if any.
    - Safe Route to School Plan improvements should be considered.
    - The applicant has been informed.
  3. Alleys Exiting onto Florence Avenue - Alleys between Marbrisa Avenue/Albany Street & Albany Street/Alameda Street. Request for Traffic Mirrors.
    - The application was denied and new signage, and/or improvements to existing signage for pedestrians/motorists, was recommended.
    - The Traffic Engineer is to prepare a work order.
    - The applicant has been informed.
  4. 3075 Randolph Street. Request to review the yield signs on the northwest corner of Randolph Street, just west of State Street, and replace them with stop signs. The issue is drivers are not yielding.
    - The Board concurred with the Traffic Engineer's recommendation to replace existing yield signs with stop signs. It was also recommended to angle the left-hand sign so that it is only visible to traffic on the right section of westbound Randolph Street and not the uninterrupted westbound traffic on the left side, and to pull in this sign east about 20 feet.
    - The yielding traffic will need a transition lane of adequate length.
    - The Traffic Engineer is to prepare a work order.
  5. 2438 E. 55th Street. Request for 30-minute Green Curb.
    - The applicant informed TA staff the on-site parking lot is not owned by him.
    - The applicant has been contacted and informed that yellow curb can be extended in front of his property.
    - The Traffic Engineer is to prepare a work order if the applicant does not reply with any objection in 30 days.
