1. All residents/business owners were notified via phone and/or email of the Traffic Authority (TA) decisions regarding their agenda item/request from the January 10, 2019 meeting.

E. NEW ITEMS

1. Gage Avenue/Bissell Street & Gage Avenue/Hollenbeck Street. Residents' concern for uncontrolled crosswalks.
2. State Street between Saturn Avenue and Florence Avenue. Pedestrian crossing safety concerns. Updated report and recommendations. City Traffic Engineer recommended Type D Pavement Markers (2-Way) for headlights on the northwest corner of Plaska Avenue (outlining the crosswalk) at the last meeting.
3. 6900 Seville Avenue. Request for Red Curb due to sight line issues.

G. OPEN DISCUSSION

1. Randolph Street between Maywood Avenue and Fishburn Street. Assigned parking for residents.
2. 6305 Marconi Street. Red Curb implemented per Fire Department approved plan without the approval of Traffic Authority.
3. Closing of 65th Street between Alameda Street and Wilson Avenue. City vacated street on February 6, 2012 by adopting City Council Resolution No. 2012-5.

H. OPEN WORK ORDERS

1. WO 18-00906: Alley Ordinance. No parking at City alleys. Vehicles to be towed per Municipal Ordinance - Install signs and inform residents.
 - Traffic Authority Item No. E1, approved September 13, 2018.
 - Work order created on November 26, 2018.
 - Citywide entrance signs installed on December 20, 2018. This is the only portion that has been completed.
2. WO 19-00986: Alleys exiting onto Florence Avenue - Alleys between Marbrisa Avenue/Albany Street & Albany Street/Alameda Street. Request for Traffic Mirrors - Install new signage and/or improve existing signage.
 - Traffic Authority Item No. C3, approved December 6, 2018.
 - Work order created on January 16, 2019.
3. WO 19-00987: 3075 Randolph St. Request to review the yield signs on the northwest corner of Randolph Street, just west of State Street, and replace them with stop signs. The issue is drivers are not yielding - Remove existing yield signs and install two new stop signs with stop bar and stop legend.

 - Work order created on January 16, 2019.
4. WO 19-00999: 2438 E. 55th St. Request for 30-min. Green Curb - Install yellow zone with signage to the west of the driveway approach for a period of time of 20-minutes.
