  - a. **City of Huntington Park had a Food Distribution in April, May and June.**

Park and Recreation director Cynthia Norzaragay informed the commission of the food distributions in the months of April, May and June that have been conducted by the department of Parks and Recreation. In April, the Senior Food Pantry was held at the Huntington Park Community Center serving over 300 cars with 1,000 boxes of food distributed. For the month of May, the food giveaway was held at Leonardo's Restaurant and over 2,000 families were served. The last food distribution in June was in conjunction with the Dodgers and over 600 cars were served. All of these food giveaways have been shepherded in a drive-thru form in practicing social distancing.
