A. <u>CASE NO. 1789-DP/CUP</u>: Consideration of a request by Rosario Espino for approval of a Development Permit and a Conditional Use Permit to construct a new two-story dwelling unit on a property currently developed with a single family dwelling unit at 3477 Flower Street, in the Neighborhood-Commercial (C-N) Zone.

Assistant Planner Garcia gave a PowerPoint presentation describing the project, which included the Municipal Code Requirements, Environmental Assessment, Administrative Comments and Analysis, and Recommendation. Mr. Garcia added that the proposed unit does comply with Municipal Code parking requirements.
