**CONDITIONS GOVERNING CONDUCT OF A GARAGE SALE:**

- A. The garage shall not be conducted in violation of any special garage sale permit regulations, any conditions of the permit, or any other applicable laws or regulations.
- B. The garage sale shall not, by the conduct of the activity, cause a threat to the preservation of the public peace, health, safety or general welfare, or unreasonably interfere with the use and enjoyment of other property in the immediate vicinity of the activity.
- C. The Community Development Director, Public Works, or Police Chief or any of their designees, shall have the authority to revoke any permit conducted in violation with any conditions of the permit issued as stated herewith, or any other applicable laws, or when in the opinion of any of the above authorities the event is being conducted in a manner potentially detrimental to the preservation of the public peace, health, safety or general welfare. Revocations shall take effect immediately or as determined by the revocating authority.
- D. The permit is only valid for dates noted on this permit.
- E. Permittee or Permittee's designated authorized representative(s), as listed in this permit, shall be present at all times the garage sale is being conducted. Such responsibility is non-transferable to any other persons.

**Special Conditions:**

- 1) No single garage/yard sale event shall operate more than 2 consecutive days.
- 2) Items offered for sale shall be limited to personal property, not acquired for resale, owned by the resident(s) of the dwelling where the sale is to be conducted;
- 3) One on-site sign advertising the sale during the sales;
- 4) All off-site advertising of garage sale must be removed on the last day of the event. Failure to removal of signage will result in a fine.
- 5) No off-site signage allowed on utility poles.
- 6) Applicant shall display Permit at all times;
- 7) Applicant shall comply with the Noise Ordinance HPMC 5-7.01;
- 8) No items shall be on the public right of way (i.e. side walk, curb or street)
