A. INTRODUCTION

B. PREVIOUS ITEMS

- 1. All residents were notified via phone and letter of the TA results of their agenda item/request from the December 10, 2015 meeting.
- 2. 6915 Miles Avenue: A blue curb at this location was denied at the November 12, 2015 TA Meeting. HP Police Department conducted a study of the green curb space to monitor parking conditions at this location. The Police Department will continue to monitor this location and give out citations to vehicles parking longer than the allotted time.
- 3. 6414 Rugby Avenue: A loading zone in front of this location was denied at the November 12, 2015 TA Meeting. As a result, of a site visit, staff noticed an existing yellow painted curb in front of the adjacent vacant medical facility. HP Police Department conducted a study to determine the use of the existing yellow curb near the address to assess if it should be converted to a regular parking space.
- 4. 3711 Broadway: A red curb request for either side of the driveway apron at this location was denied at the December 10, 2015 TA meeting. HP Police Department will conduct a 30-day study at this location to see if neighbors are parking in front of the resident's driveway and give out warnings.
- 5. 2059 Belgrave Avenue: A red curb was requested to be painted across the yard entrance to a trucking facility and was motioned to be held off until

D. UPDATES

- 1. School Site Circulation report update for **Nimitz Middle School** (6th-8th) 6021 Carmelita Ave; **Huntington Park Elementary School** (K-5th) 6055 Corona Ave, and **Aspire Antonio Maria Lugo Academy** (K-5th) 6100 Carmelita Avenue. On December 16, 2015 the Police Department in conjunction with City Traffic Engineering conducted a test by closing off northbound and southbound traffic at the intersection of Carmelita Avenue and Randolph Street between the railroad tracks. All northbound and southbound traffic was directed along Randolph Street in the eastbound and westbound direction. This was done to analyze the change in traffic flow and see if the queuing on Carmelita Ave between Randolph St and 61st St would clear more rapidly during schools let out.
- 2. PW painted the curb red along the 13-foot curb in front of the residence located at 3726 Hill Street on December 16, 2015.
