## D. UPDATES

- Alameda Street and Saturn Avenue: Alliance Collins Family College Ready High School & Aspire Centennial College Preparatory Academy. Resident request to monitor traffic circulation. Traffic related concerns occur during peak hours (drop-off and pick-up). – Request received through the City Manager's Office: Citizen Inquiry Log (2/12/18).
  - A. Traffic Consultants coordinated with school and observed drop-off and pick-up process and determined that traffic circulation concerns occurred at peak morning and afternoon hours and was not a safety concern.
  - B. Traffic Authority staff discussed the concerns of the applicant and motioned to deny the applicant's request to cone off a section of Saturn Street east of Alameda Street to use as a drop-off/pick-up area for students.
