A. INTRODUCTION

B. PREVIOUS ITEMS

1. All residents/business owners were notified via phone of the Traffic Authority (TA) results of their agenda item/request from the August 2, 2018 meeting.

C. NEW ITEMS

1. 6613 Plaska Avenue. Request to add speed cushions/speed humps to reduce speeding. Traffic report now able to be provided with school back in session.
2. 6500 Cottage St. Request for Blue Curb. The applicant states there is no garage on-site but there is a driveway. However, because he is a tenant with multiple units on the property (less than 5), the driveway is not his to use.
3. 6417 Hollenbeck St. Request for speed cushions/speed humps to discourage speeding along the alley to the north.
4. 6625 Arbutus Ave. Request for speed cushions/speed humps along the entire block.

D. UPDATES

1. 6212 Plaska Avenue. Request for Red Curb to allow ingress and egress from driveway. Applicant states police have been called but no action has been taken on their part.
 - The decision of TA meeting on August 2 for selective police enforcement was conveyed to the resident.
 - Police Chief to provide update on Ordinance about allowing citations for

- blocking any portion of driveway by vehicles?
2. Request to revise hours of Permit Parking at the City Hall parking lot located at 6550 Miles Avenue.
 - City Hall Permit Parking spaces to be posted with "No Parking 24 Hours Without a Parking Permit."
 - City Hall designated/reserved parking spaces (Directors, members of City Council, City Clerk, etc.) to be "No Parking Without Permit Any Time."
 - Traffic Engineer to issue Work Order once Public Works Director/City Manager approve language to be posted.
 3. Aspire Pacific Academy, 2565 E. 58th Street. Request to make alley south of the school into a one-way alley.
 - School administrators have been contacted and will be informed of the TA decision denying their request once item has been floated to the City Manager and possibly City Council.
 4. Vehicle and pedestrian traffic concerns at Linda Esperanza Marquez High School, 6361 Cottage Street. Updated report.
 - The Board authorized the Traffic Engineer to submit a "Service Request" to LA County Department of Public Works to review and address the concerns.
 - As an interim measure, the Board authorized the Traffic Engineer to design and plan to implement no parking and no U-turn on Cottage Avenue near the entrance to the school.
 - The Board motioned to approve painting the curb red at the front of the school and taking out 2 on-street parking spaces. TA staff to give the final Work Order to the Public Works Director to show to the City Manager first who will then inform City Council about the removal of the 2 on-street parking spots.
 - School administrators have been contacted and will be informed of the TA decision once item has been floated to the City Manager/City Council.
