DANCE AND ENTERTAINMENT PERMIT APPLICATION GUIDELINES

In accordance with Huntington Park Municipal Code Title 9 Chapter 2 Article 12 and Article 13 the following is required for a Dance and Entertainment Permit. Complete the application and all accompanying forms legibly in black or dark blue ink. Forms completed in pencil will be returned. All authorized individuals must sign and date the forms, where applicable. Incomplete applications will not be accepted. Use additional sheets if necessary.

Submittal Requirements:

- Complete Dance and Entertainment Permit Application
- Copy of Valid Identification Card
- Completed Livescan
- Copy of *Active* City Business License
- Copy of *Active* CA Seller's Permit
- Copy of *Active* LA County Health Department Permit
- Copy of *Active* Alcoholic Beverage Control License with Conditions
- Interior Floor Plan to identify:
 - Dimensions of interior floor plan, including square footage
 - Location inside the establishment where dance/ entertainment activities are proposed to take place
 - Indicate locations of all entrance and exit doors
 - Identify location of all seating throughout
 - Dance floor dimensions and type of flooring materials used
 - If a stage is proposed, give exact measurements including height, location, and materials used
- *Additional information may be requested upon formal submittal*

Required Fees:

- \$ 2,600.00 for New Dance and Entertainment Permit

How is the application processed?

The application will be reviewed by City Departments. If additional information is required, the applicant will be contacted. After the application is deemed complete, item will be scheduled for the next appropriate City Council Meeting. The applicant is responsible for routing the application to outside agencies.
