VOLUNTEER RELEASE AND WAIVER OF LIABILITY

This Release and Waiver of Liability (the "Release") executed today by the undersigned "Volunteer", in favor of the City of Huntington Park, its officers, directors, employees and agents (collectively, "CITY").

The Volunteer desires to work as a volunteer for CITY and engage in the activities related to being a volunteer (the "Activities"). The Volunteer acknowledges that he or she is not an employee of CITY, and that he or she desires to donate their services without contemplation of pay for public service or humanitarian objectives. The Volunteer hereby freely, voluntarily, and without duress executes this Release under the following terms:

Release and Waiver. Volunteer does hereby release and forever discharge and hold harmless CITY and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with CITY.

Volunteer understands that this Release discharges CITY from any liability or claim that the Volunteer may have against CITY with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Volunteer's Activities with CITY, whether caused by the negligence of CITY or its officers, directors, employees, or agents or otherwise. Volunteer also understands that CITY does not assume any responsibility for nor obligation to provide financial assistance or other assistance, including but not limited to medical, health, disability insurance, and workers' compensation in the event of injury or illness.

It is the policy of CITY that the minimum age to volunteer is age 18. Volunteer represents and warrants that Volunteer is at least 18 years of age.

Medical Treatment. Volunteer does hereby release and forever discharge CITY from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with CITY or with the decision by any representative or agent of CITY to exercise the power to consent to medical or dental treatment.

Assumption of Risk. Volunteer understands that the Activities include work that may be hazardous (that is, that can cause serious physical injury or death) to the Volunteer. Volunteer agrees to work with full knowledge of the dangers and potential injuries involved. Volunteer hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases CITY from all liability for injury, illness, death, or property damage resulting from the Activities and/or Volunteer's negligence. Volunteer also agrees to indemnify CITY for any injury Volunteer may cause to another.

Insurance. Volunteer understands that, except as otherwise agreed to by CITY in writing, CITY does not carry or maintain health, medical, disability, or workers' compensation coverage for any Volunteer. Each Volunteer is expected and encouraged to obtain his or her own medical or health insurance coverage.

Photographic Release. Volunteer does hereby grant and convey unto CITY all rights, title, and interest in any and all photographic images and video or audio recordings made by CITY during the Volunteer's Activities with CITY, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings and the right to publicly display or utilize such images and recordings, including specifically the images and recordings of Volunteer, in advertising and for promotional and other purposes.

Other. Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of California, and that this Release shall be governed by and interpreted in accordance with the laws of the State of California. Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
